Welcome Jackie South (DAFF)

Jackie welcomed participants to the Forum and outlined the national framework for RD&E Strategies. She emphasised that the PISC process is working towards:

- Greater co-ordination in innovation and RD&E in the primary industries sector.
- Should **Optimise** use of available resources by improved
 - **Harmonisation** of efforts,
 - **Collaboration** on projects,
 - national research **Capability**

Forum overview Alan Tilbrook (SARDI/Animal Welfare Science Centre)

Alan outlined the Forum program and reminded participants that in their deliberations towards prioritising and scoping identified projects that they should bear in mind that these projects should be:

Nationally Significant

High priority

Cross-sectoral and require significant

Collaboration

Session 1

Project Development process Darryl D'Souza (Australian Pork Limited)

Darryl gave a presentation on the National AW RD&E Strategy project development process which will improve the timeliness of project application and approval.

Session 2

Project report: “Identify and integrate measures of animal welfare that meet the needs of animals and society”

Paul Hemsworth (AWSC) on behalf of Drewe Ferguson (CSIRO)

Main discussion points:

- Application is clear and suitable for intensive livestock production; the application is less clear for extensive sectors. Need to determine the drivers to adoption for each sector.
- If geared to establishing the welfare credentials of a particular livestock sector for the export market, most markets do not rate AW highly.
- AWI is developing a welfare matrix for wool in response to customer demand

Project Update: “Develop a public attitude monitoring scheme (ie monitoring public attitudes to inform animal welfare policy development)”

Vanessa Rohlf (AWSC)

Main discussion points:

- Will generate information on industry knowledge of opinion leaders.
- An apparently similar project recently undertaken at Central Queensland University could inform this project.

ARC Linkage Project Update: “Getting to the Meat of the Matter: Social & Economic Issues in Animal Welfare in Australia’s Livestock Industries”

Rachel Ankeny and Wendy Umberger (Univ Adelaide)

Rachel and Wendy outlined the aims and method of this ARC linkage project. In particular, the project aims to:

- Develop a whole-of-chain approach to understanding animal welfare along the animal production value chain in Australia
- Determine how these perceptions influence consumer and industry behaviours
- Provide insight on how to foster better alignment between industry practices and consumer demands

Partners include DAFF, Coles, Elders, SARDI and Richard Gunner’s Fine Meats.

Session 3

Pre-Forum Survey report

Jeremy Skuse AWSC

Jeremy outlined the results of the pre-forum survey which indicated the following 5 project/areas which were supported for discussion at the Forum:

1. Investigate positive welfare states / handling procedures to mitigate aversive practices
2. Develop a better understanding of what prevents/inhibits adoption and develop more effective methods for technology transfer. Cross sector/strategy
3. Develop whole of chain animal welfare programs which include objective standards and training.
4. Develop stockperson training packages for all sectors
5. Commission work to identify current and emerging gaps in Australian animal welfare RD&E capability and recommend strategies to address these gaps

Project discussion/shortlisting

Facilitated by Alan Tilbrook (SARDI/Animal Welfare Science Centre)

General Discussion points following presentations:

- Public often have strong opinions based on little or no knowledge
- Community expectations are often at odds with what is achievable by industry
- When 'educating' the community, science messages can be 'off-putting' to the community and it may be best to convey simple messages that build trust as most people don't want to know the 'nuts and bolts' of the argument
- Science is not always the answer - the pork industry could not effectively defend the use of stalls so decided to introduce the 'Building our Future' program and sought and obtained industry backing for a voluntary ban on sow stalls
- The dairy industry has launched the 'Legendary' campaign which seeks to emphasise the role of dairy by telling the stories of the people behind the product and the quality and sustainable nature of the products they produce and their contribution to the Australian economy. The dairy industry's focus is on extension in targeted areas
- Messages to the community must demonstrate public good
- The area of understanding/measuring community/consumer attitudes and behaviour together with community/consumer education is a huge area and may benefit from a 'working party' which would be cross-sectoral and cross-strategy and address the issues of welfare, environment, etc.

The discussion then moved to work which was being performed or proposed in Australia which may not be known to all, examples were:

- AWSC thinking around an ARC linkage project looking at positive human-animal relationships and stress resilience

- CSIRO post-doc looking at affective states in sheep
- CSU training package in overseas live export markets - funded by MLA
- UNE/CSIRO review of new approaches to assess welfare in free range laying hens
- UNE/CSIRO/SARDI/UoA/AWSC developing collaborative program to determine stocking density for free range laying hens
- OIE Collaborating centre twinning proposal and pilot AW training program in SE Asia
- MLA commercial-in-confidence work on new analgesics
- MLA/UQ and MLA/AWI work looking at novel delivery methods for pain relief
- Uni Adelaide internally funded project looking at how families talk to kids about meat
- Uni Syd/AWI work on measuring producer attitudes to pain relief
- Novatec analgesia before beak trimming
- Sheep CRC extension has a wellbeing and productivity program
- CSIRO/UNE/Uni Syd doing work to develop biomarkers to assess both positive and negative welfare states
- Coleman is doing work on adoption funded by AMPC
- UWA/AWSC are investigating the integration of ProHand in low-stress sheep handling package funded by MLA
- Uni Syd is building capability in remote sensing technologies

As a result of this discussion, the Forum suggested the following:

- A register of projects and capability should be developed and maintained
- Funders will be the initial source of information
- Animal Welfare research activity collated will initially be in the livestock sector but will be widened to include other activity from other sectors which has relevance to the livestock sector
- Any such register must have a 'champion' who will ensure that information is gathered from relevant sources
- Executive Officer will gather information on above activities and circulate

Alan called for additional project ideas for consideration, 4 additional projects were identified:

1. Pain measurement
2. Integrated approach to invasive procedures
3. Novel ways to measure positive or negative welfare
4. Develop a platform to "host" animal welfare RD&E activity

Attendees were split into 6 groups and were asked to consider the projects identified by the survey together with those identified at the Forum and to cast votes for the 'top' four priority projects.

Attendees were reminded that when considering the projects that they should bear in mind the need to identify projects which would be nationally significant, high priority, cross-sectoral in application and require significant collaboration.

The 'top' four projects identified were (in order)

1. Develop a platform to "host" animal welfare RD&E activity
2. Investigate positive welfare states / handling procedures to mitigate aversive practices
3. Commission work to identify current and emerging gaps in Australian animal welfare RD&E capability and recommend strategies to address these gaps
4. Pain measurement

Because a project brief to commission work to identify current and emerging gaps in Australian animal welfare RD&E capability and recommend strategies to address these gaps has already been presented to the Steering Committee, Forum attendees were asked to scope the other 3 projects and present their findings to the group.

<i>Indicative resources required?</i>	Up to \$25k to establish the register and populate (2013-14) \$10k pa thereafter to maintain

Plenary session – feedback

- Seen as a core part of the Strategy
- Collecting information re quality and capability might be out of the scope of the project but could inform any future work to assess capability etc
- Work in developmental stage may not be shared due to commercial or competitive constraints
- Essential that updating takes place otherwise the work will be irrelevant
- Strong driver required to obtain information for updates.
- Important to gather information on non-livestock AW RD&E as may be useful to the livestock sector
